  - o Talent needs to be all in one track, the DJ will not play multiple.

# **Judging Categories**

Contestants are judged on the following categories (all scoring is accumulative **not** comparative)

Miss Central WI Pride: Interview, Evening Gown, & Talent Mr. Central WI Pride: Interview, Formal Wear, & Talent

#### Interview

The interview category is your way of making a first impression to the judge's panel. Think of this category as a job interview. You will be judged on confidence, ability to answer questions, and communication skills.

- Interview is limited to no more than seven (7) minutes in length.
- Each contestant will be interviewed individually by the panel and will be asked any number of questions to understand you as an individual
  - Entertainer life, personal life, professional life, etc.
- This is not a fashion category, and formal attire is not required.

#### Mr. - Formal Wear

Contestants will be judged on modeling, fit, confidence, and overall look. House music will be provided for this category. Formal Wear is NOT comparative.

- Formal wear is defined as a full suit or tuxedo. This should be nicely fitted and tailored to your body.
  - o You will **NOT** be judged on your weight and physique
  - Pants should be tailored to not bunch at the heels.
  - Sleeves no shorter than the wrist.
  - Shoes should match or complement the suit and should be free of scuffs or wear/tear.
  - o Garment should be free of loose strings, tears, stains, and wrinkles.
- Formal wear may include embellishments to enhance the look, but avoid making it look too much like a costume.
- Judges should **not** be able to see through any part of the garment.
- Accessories are encouraged but should not be overpowering.
- Modeling should be at a slow and easy pace. Target fixed points on the stage/floor to stop and pose to show your modeling skills.
  - O Judges will be watching to see how well you can move in the garment.

#### Miss - Gown

Contestants will be judged on modeling, fit, hair, makeup, accessories, and overall look. House music will be provided for this category. Gown is NOT comparative.

- A gown is defined as something you would wear to a formal event.
  - o The garment should complement your figure and show your style and taste.
    - You will NOT be judged on your weight and physique.
  - o The garment should be floor length.
    - Floor length is defined as past the ankle and hitting the floor. You are welcome to have a train if that is part of your look.
  - The garment may include embellishments to enhance the look but avoid making it look too much like a costume.
  - o Garment should be free of loose strings, tears, stains, and wrinkles.
- Hair should complement your overall look.
  - Hair does **NOT** need to be an updo, but it should be clean and smooth and allow for proper modeling (ex. Hair getting caught on sequins or accessories can restrict head and shoulder movement).
- Accessories should complement the overall look.
  - Accessories should be in perfect condition free of missing stones, glue residue, or any marks.
- Modeling should be at a slow and easy pace. Target fixed points on the stage/floor to stop and pose to show your modeling skills.
  - O Judges will be watching to see how well you can move in the garment.

#### **Talent**

Talent may be any type of entertainment presentation, as long as it does not create any danger to the contestant or anyone else.

- Talent is limited to no more than seven (7) minutes in length.
- Prop set-up and take down is limited to two (2) minutes each.
  - This means you have 2 minutes before your talent and 2 minutes after your talent.
  - o If you exceed this time, administrative points may be deducted from your final score
- There is no restriction to the number of persons who may be involved in a contestant's talent number.
- Talent may not involve fire, water, glitter, confetti, or strobe lighting.
- No other lighting will be provided by the DJ
  - Judging of your talent will not start until your music begins (to allow for setup of props if needed)

### Rules

The following are rules that must be followed during the competition. Breaking of these rules may be subject to disqualification or loss of administrative points.

- 1. Contestants for Mr./Miss Central WI Pride may be any gender identity but must be at least 21 years of age.
  - a. You may be asked to show proof of age.
- 2. Judging will be scored using a standard accumulative scoring system.
  - a. A tie breaker will be determined by the highest Talent score.
  - b. If Talent scores are a tie, Interview score will be the tie breaker.
  - c. If Talent and Interview scores are a tie, Gown/Formal will be a tie breaker.
- 3. All dancers, dressers, or other attendees must be at least 21 years of age.
- 4. All contestants must be in good standing with organizations, businesses, or sponsoring entities throughout the state of Wisconsin and not on parole or pending any sort of legal action.
  - a. This includes parole, probation, incarceration, or supervision.
- 5. Contestants will be allowed one dresser backstage. If you have multiple people helping you then you will need to make sure they hand off the backstage pass to one another as administrative points will be deducted should you have more than one dresser at the same time.
- 6. No contestant, dancer, or dresser shall be under the influence of illegal substances or greatly impaired by alcohol during any part of the contest. Any contestant who is found to be under the influence will be disqualified, with no return of any monies paid.
- 7. Any contestant, dresser, dancer, etc. who is caught in the act of stealing or tampering with another person's property (or the venue's), or any physical altercations with anyone on the premises will be disgualified and removed on the spot immediately, no questions asked.
- 8. No tipping of contestants will be allowed during any point of the competition. The acceptance of gifts, tips, or tokens such as flowers from the audience will automatically disqualify the contestant.
- 9. The winning contestants agree to represent the titles of Mr./Miss Central WI Pride for the year with decorum and dignity without controversy.
- 10. Due to limited time, any contestant who is not on time or where they need to be for their Gown, Talent, or Interview category will be skipped and will receive no points for that category.
- 11. The dressing room is to be kept clean and organized. Due to the space that contestants will be dressing in, there is to be nothing placed on vehicles. If you do make a mess, it is your responsibility to clean it up before the nights end. If you do not, this will hinder your chance to come back the following year if you choose.

The promoters of Mr./Miss Central WI Pride reserve the right to make any decisions concerning any matter not covered by these rules and regulations. If you have any questions pertaining to these rules or need further clarification, please consult Mistruss Lola.

Any winning contestant who does not adhere to the rules will be removed from the position of Mr./Miss Central WI Pride, therefore, handed down to the 1st alternate who will then receive the title with crown & sash, obtain the responsibilities, and prize monies that were awarded to the winner (all of this given back from said person due to non-fulfillment).

# **Obligations**

The following are obligations to be held by the title holders as well as the promoters of Mr./Miss Central WI Pride.

#### Title Holder

- 1. All entertaining and/or appearances as the official representative of Central WI Pride must be held to the highest standards. The titleholder is an official representative of Central WI Pride, and therefore is representing Central WI Pride during their reign. This includes (but is not limited to):
  - a. Not appearing uncontrollably drunk in a public place.
  - b. Not to commit acts of a sexual nature in a public place.
  - c. Not to commit acts of a violent nature in a public place.
  - d. Not to use illegal drugs in a public place.
  - e. Not to commit acts of stealing.
  - f. Not to participate in malicious gossip in public or in any social media forum.
  - g. Not to be deemed guilty of any other unreasonable act that is considered demeaning to the title.
  - h. Not to perform completely nude at any time.
- 2. The titleholder agrees to keep a valid form of communication during the year of their reign.
- 3. Title holders are obligated to return for their step down the following year.

#### Promoter

- 1. To provide the titleholder with all necessary information on a timely basis, as available, concerning obligated bookings.
- 2. To pay all monies, awards, and prizes, if the titleholder is not in default under this contract.
  - a. \$150 Cash
  - b. Crown and Sash at time of winning

# **Rights**

The following are rights held by the title holders as well as the promoters of Mr./Miss Central WI Pride.

#### Title Holder

- 1. To enjoy the privileges of said title.
- 2. Move freely throughout the United States.
- 3. To participate in Mr./Miss Wisconsin Club.
  - a. This is **not** a requirement for the reigning Mr./Miss Central WI Pride. If you choose not to run, your title will not be revoked but we highly encourage you to run!

#### Promoter

- 1. To always have and retain paramount title to the Central WI Pride title.
- 2. To change the title of Mr./Miss Central WI Pride at its own discretion.
- 3. Revoke the title without question if this contract is in default.
- 4. To reasonably set forth rules and regulations concerning the conduct of titleholders.
- 5. To set the dates, times, and future Mr./Miss Central WI Pride contest.

# **Promoter's remedies**

If titleholder defaults under this contract, the promoter may treat any one or more of the foregoing occurrences as a breach of this contract, and thereupon at its option may, without notice or demand of any kind (which titleholder hereby expressly waives), to titleholder or any other person, have, but not limited to, any or all the following remedies.

- 1. Revoke the title from the titleholder.
- 2. Demand the return of all prizes, awards, and/or monies given to titleholder.
- 3. Pass the title to the 1st Alternate.
- 4. To assess fines for breach of any or all the contracts. Said fines shall not exceed the amount of \$500 per offense but may at a lower amount as set forth and determined by The Central WI Pride promoters.

## Release

By my signature below, I hereby agree to release and hold harmless, promoters of the official Miss/Mr. Central WI Pride Contest, their agents, and employees from any liabilities, and/or responsibilities whatsoever resulting from, associated with, or arising out of my participation in the Contest or any related activities. I also hereby release myself from any rights to any videotaping (sound and/or video), photography, recording, still camera or motion pictures of the contest. I understand that I have no rights to any of the recordings that I appear in/on or the future sales thereof. I hereby agree that my name or any photographs taken of me during the Contest may be used for publication for promotional purposes or in any advertising publicity.
